Equestrian Canada Statement of Principle

Equestrian Canada (EC), the national equestrian federation of Canada, supports adherence to humane treatment of horses in all activities under its jurisdiction.

All persons shall be committed to:

- Upholding the welfare of horses, regardless of value, as a primary consideration in all activities;
- Requiring that horses be treated with kindness, respect, and compassion, and that they never be subjected to mistreatment.
- Ensuring that owners, trainers and exhibitors or their agents use responsible care in the handling, treatment and transportation of their horses as well as horses placed in their care for any purpose.
- Providing for the continuous well-being of horses by encouraging routine inspection and consultation with health care professionals and competition officials to achieve the highest possible standards of nutrition, health, comfort and safety as a matter of standard operating procedure.
- Continuing to support scientific studies on equine health and welfare;
- Requiring owners, trainers, and exhibitors to know and follow their sanctioning organization's rules and to work within industry regulations in all equestrian competitions;
- Reviewing, revising and developing competition rules and regulations that protect the welfare of the horses

The standard by which conduct or treatment will be measured is that which a person who is informed and experienced in generally accepted equine training and exhibition procedures would determine to be neither cruel, abusive, nor inhumane.

Equestrian Canada Gold Show Information

The Tilted Tiara competition is sanctioned as a Platinum competition of Equestrian Canada c/o House of Sport 2451 Riverside Drive, Ottawa, Ontario, K1H 7X7 and is governed by the rules of EC. (A602.1)

Every class offered herein is covered by the rules and specifications of the current rules of EC and will be held and judged in accordance with the EC Rule Book. (A602.2)

Per Article A801, every entry at an EC-sanctioned competition shall constitute an agreement by the person(s) responsible that the owner, lessee, trainer, manager, agent, coach, driver or rider and horse shall be subject to the EC constitution and all rules of EC and any additional rules set by the competition. It is the responsibility of all individuals participating in any capacity in EC-sanctioned competitions to be knowledgeable regarding the EC constitution and the applicable rules of EC and the additional rules, if any, imposed by the competition. Do not participate in this EC-sanctioned competition in any capacity if you do not consent to be bound by the constitution and rules of EC and any additional rules imposed by the competition. (A602.7)

When registering for EC sanctioned competitions, athletes must indicate the name of their coach on the entry form or specify that they are self-coached. Coaches from other countries, must be in good-standing with their home federation and must declare/have proof of insurance. See Rules of Equestrian Canada, Section A, General Regulations, Article 102, Safe Sport Environments.

All horses attending Equestrian Canada sanctioned competitions must have met the requirements of Article A519, Vaccinations. See Rules of Equestrian Canada, Section A, General Regulations, Article A519, Vaccinations (A602.8)

Any horse entered in any class at a competition may be selected for equine medication control while at the event location. (A602.5)

In order to enter a horse in an EC sanctioned competition, you must designate a Person Responsible (PR). The PR must be an adult who has or shares responsibility for the care, training, custody and performance of the horse, and who has official responsibility for that horse under EC Rules. The PR is liable under penalty provisions of the applicable EC Rules for any rule violations. Every entry form for an EC sanctioned competition must identify the PR and be signed by the PR.

Temporary Sport Licences and Horse Recordings are no longer available for purchase.

ALL riders, owners, and coaches **must** hold at minimum a Bronze Sport Licence (exceptions only in A213).

Single Event Upgrades are available for purchase directly through the competitors MyEC portal. There is a flat rate of \$55 per upgrade, regardless of levels being upgraded. Upgrades are not available to Platinum.

All horses who require a Horse Recording must have a Horse Recording activated prior to the event, Horse Recordings can be purchased digitally via MyEC. There is no alternative temporary option available.



EC SPORT LICENSING 2025

SAFETY, INCLUSIVITY, & EXCELLENCE

Your guide to the latest updates for the competition season in Canada

IMPORTANT CHANGES have been implemented to enhance the safety and inclusivity of equestrian sport. Whether you're an athlete, parent, coach, official, or competition staff, your role is crucial in upholding these standards. Here's what you need to know:

SAFE SPORT TRAINING PREREQUISITE:

- The two free EC Safe Sport training modules must be completed before purchasing a Sport Licence. Check your training status on MyEC by clicking on the ECampus button.

DISCONTINUED TEMPORARY LICENCES AND TEMPORARY HORSE REGISTRATIONS:

- Temporary EC Sport Licences are now discontinued at competitions. All riders, owners, and coaches must possess an EC Sport Licence to participate in events. All horses must have a Horse Recording where level and division require.

AVAILABLE SHOW LEVEL UPGRADES:

- Explore higher-level competitions with temporary upgrades via your MyEC Portal. Note: National Rankings Points are not tabulated for upgraded results.

COACH STATUS REQUIREMENTS:

- All coaches at EC-sanctioned events require EC Licensed Coach Status. For upgrading from Registered to Licensed Status, coaches can apply for a Temporary Coach Status (TCS) to fulfill the requirement for each event.
- New for 2025: A TCS may be purchased conveniently online via the MyEC Portal only. Each TCS is valid for a single event.

EMPOWERING SELF-COACHED ATHLETES:

- Athletes without a coach on-site can declare themselves as self-coached by providing their name and EC Sport Licence number on their entry form. Coaches that are not present at the event with the athlete are not to be listed on the entry form.

FEI Vaccination Requirements

When your veterinarian administers an equine influenza vaccine to an FEI Horse, they must update the vaccination details on the FEI HorseApp in addition to recording them in the horse's FEI Passport.

🔑 Key Requirements (FEI Veterinary Regulations):

- ✓ Same-day entry: Vaccination details must be entered into the FEI HorseApp on the day of administration.
- ✓ Complete information: The entry must include the vaccine name and batch number.
- ✓ Veterinarian presence: The veterinarian must be present with the horse at the time of entry.

FEI Horse Health Requirements

All CDI horses stabled in the FEI barns must adhere to the latest **FEI Horse Health Protocols** as outlined in **Articles 1029 and 1031** of the FEI Veterinary Regulations.

📌 Key Requirements for ALL Horses Competing at FEI Events:

✅ Pre-Arrival Temperature Monitoring

- Record **two daily temperature readings** for **three days prior to arrival** at the event.
- Enter these readings in the **FEI HorseApp**.

✅ Horse Health FEI Self-Certification Form

- Complete and submit the form via the **FEI HorseApp** the **day before or the day of arrival** at the CDI.

✅ On-Site Temperature Monitoring

- Take and record **twice-daily temperature readings** for each horse throughout the CDI using your **own thermometer**.
- Enter the measurements directly in the **FEI HorseApp**.

Failure to comply with these regulations may result in penalties or disqualification.

Tilted Tiara CDI – Competition Categories & Requirements

The Tilted Tiara CDI offers a range of FEI-sanctioned divisions, each with specific eligibility criteria and class offerings:

CDIAm (Amateur)

- **Eligibility:** Athletes 26 years and older with no ranking on the FEI Dressage World Ranking List at the time of definite entry.
- **Horse Limit:** 1 horse per athlete
- **Tests:** Prix St. Georges, Intermediate I, Intermediate I Freestyle (*Freestyle is optional*).

CDI1*

- **Horse Limit:** 2 horses per athlete
- **Tests:** Prix St. Georges, Intermediate I, Intermediate I Freestyle (*Freestyle is optional*).

CDI2*

- **Horse Limit:** 1 horse per athlete
- **Tests:** Intermediate B, Intermediate II, Intermediate A/B Freestyle (*Freestyle is optional*).

CDI3*

- **Horse Limit:** 2 horses per athlete
- **Tests:** Grand Prix, Grand Prix Special, Grand Prix Freestyle.
- **Athletes must choose between the Grand Prix Special and the Grand Prix Freestyle.**

CDICh (Children)



- **Horse Limit: 1 horse per athlete**
- **Tests:** Children's Preliminary, Children's Team, Children's Individual (*Individual is optional*).

CDIJ (Juniors)

- **Horse Limit: 2 horses per athlete**
- **Tests:** Junior Team, Junior Individual, Junior Freestyle (*Freestyle is optional*).

CDIY (Young Riders)

- **Horse Limit: 2 horses per athlete**
- **Tests:** Young Rider Team, Young Rider Individual, Young Rider Freestyle (*Freestyle is optional*).

CDIU25 (Under 25)

- **Horse Limit: 1 horse per athlete**
- **Tests:** Intermediate II, Grand Prix 16-25, Grand Prix Freestyle (*Freestyle is optional*).

FEI Veterinary Requirements

The veterinary requirements for the CPEDI are the same as for the CDI.

Tilted Tiara CPEDI – Competition Categories & Requirements

Under **FEI Para-Dressage Rules**, all **CPEDI competitions** must provide equal opportunities for athletes across all **five Grades (I–V)**. This ensures inclusivity and fair competition for para-equestrian athletes at all levels.

Key Requirements:

1. Mandatory Class Offerings for All Grades

- **Individual, Team, and Freestyle** tests are offered for **all Grades (I–V)**.
- Athletes compete within their designated Grade based on their classification.
- Athletes must have a valid **FEI Para-Dressage Classification** and compete in their assigned **Grade (I–V)**.
- Competitions cannot restrict or limit entries to certain Grades.
- The Freestyle is **optional** and available for all grades.

2. Event Levels (CPEDI1*, CPEDI2, CPEDI3*)

- **CPEDI1***: Novice A, B and Freestyle Tests for all grades.
- **CPEDI2***: Intermediate A, B and Freestyle tests for all grades.
- **CPEDI3***: Grand Prix A, B and Freestyle tests for all grades.

Alberta Equestrian Federation Wild Rose Show Information

The Tilted Tiara I Competition is sanctioned as an Alberta Wild Rose **Provincial Circuit Competition** and will be run in accordance with the AEF Wild Rose **Competition Rulebook**.

Every participant at the AEF Wild Rose Competition shall agree that the owner, lessee, trainer, manager, agent, coach, driver or rider, and horse shall be subject to the constitution and rules of the competition.

Every class offered herein is covered by the rules and specifications of the current Wild Rose Competition Rulebook and will be judged in accordance with the Rulebook.

Any horse entered in any class at a competition may be selected for equine medication control testing while at the event location.

When registering for Wild Rose sanctioned competitions, athletes must indicate the name of their coach on the entry form or indicate they are self-coached.

All horses participating in the Wild Rose provincial circuit competition must have received Equine Influenza and Equine Herpes Virus (1&4) vaccinations within the last 6 months, with a 21-day grace period before the event.

Entries in the Wild Rose show only require an AEF (or other Provincial) membership for the rider. Eventing Combined tests, Eventing Dressage tests and Western Dressage tests are offered as part of the Wild Rose show. All classes in the Wild Rose show are not rated for EC awards.



Entry Information Gold & Wild Rose

Rules

01. All entries must be submitted through BlackHorse One.
<https://blackhorse-one.com/equestrian-hub>
02. Entries for the Gold and Wild Rose shows will be processed in the order they are received. The organizing committee reserves the right to limit or refuse entries subject to championship rules limiting a competition's right to refuse entries. A805.
03. Riders may pay one administration fee and enter both Gold and Wild Rose classes.
04. The Master's Test of Choice Class is an EC dressage class that provides senior riders, 60 and older, the opportunity to participate in a dressage class that is exclusively their own that provides a fair playing field for senior riders wherein each will compete against their peers at all levels of skill, from beginner to advanced. The class will feature one test per day. Please review EC rules for the list of accommodations available.
05. Please submit your Freestyle Music when registering; the music must be electronic. Please email the show secretary with the music file.
06. Gold entries must pay a mandatory DC Levy of \$10, and a mandatory Drug Fee of \$8.
07. Late entries will be accepted, space permitting, with a late fee.
08. Post entries to fill scratches will be allowed if scheduling permits. To be eligible for post-entry into classes, the horse/rider must already be registered as a competing or non-competing horse and must arrange the additional classes with the show secretary.
09. All entries must have the signature of the owner or authorized agent and the signature for the person(s) responsible for the horse. Riders will not be allowed to compete without a person(s) responsible signature.
10. Junior riders must have permission to participate in the show as indicated by the signature of a parent or guardian.
11. Hors Concours entries will be accepted with full fees. Entrants are subject to EC or AEF rules, and Hors Concours entries are not eligible for ribbons or awards.
12. Non-competing (schooling horses) will be accepted. Entries must pay the administration fee, the schooling fee and stabling fees. Schooling horses do not require a horse recording. Riders must have proof of AEF or provincial membership.
13. **There will be Jumper Rounds on Friday and Saturday.** Each horse may enter a maximum of 4 rounds per day, with no more than 2 rounds at the same height per day. Warm-up ring will be provided.

No scoring or prizes will be awarded. For a true show experience, rounds will follow regular jumper rules, including elimination for refusals, off-course, and falls. Jumper round fee is \$50 per horse, per day, which includes all jumper rounds for that day. Pre-registration is strongly encouraged should capacity be reached.
14. Riders may scratch their entry online.

Before the entry closing date, the scratch fee is \$50.

After the closing date and before May 18 at 4 pm, the scratch fee is \$150.

After May 18 at 4pm, and before May 20 at 1 pm, the scratch fee is \$250.

There are no refunds after May 20 at 1 pm.

All fees in excess of the scratch fee will be refunded to your credit card. All stabling, shavings, classes, ride times etc, will revert to Tilted Tiara, who will reassign if possible.
15. Horse substitutions are allowed until one hour before the horse competes in their class. The name of the horse, any required licences and the owner or person(s) responsible signatures must be given to the show secretary when the substitution is made.
16. All athletes, regardless of age or level of competition, must wear properly fitted and fastened safety approved protective headgear at all times when mounted.
17. Exhibitors must be ready to compete when scheduled.
18. The horse may compete at any level up to a maximum of four tests per day, including the freestyle e.g. one horse could compete on a total of four technical tests, with two different riders each riding two tests. The horse may compete only in two consecutive levels. Horses competing at second level and above can only compete in three technical tests per day.



19. The show will provide no test readers.
20. Every entry must have an identification number worn and visible on the show grounds. The show will not provide entry numbers to competitions. Competitors must bring their own numbers.
21. Any horse receiving less than 50% of the total points obtainable in a test shall not be eligible for awards, ribbons, or prizes. (E9.10.7)
22. When there is only one horse in a class, ribbons and prizes shall be awarded in accordance with the following chart of percentages:

1st	63% or higher
2nd	60% to 62.9%
3rd.....	58% to 59.9%
No ribbons or prizes shall be awarded below 3rd position. (E9.9.10)	
23. Class ribbons can be picked up at the show office.
24. Class ribbons will be given to 6th place.
25. Warm-up in the dressage show rings is allowed on the move-in day from 2:00 PM until 8:00 PM. Horses not stabled on the grounds may also haul-in on move-in day and school in the dressage show rings. Schooling in the dressage show rings is also allowed for one hour after the last rider in that ring on the first show day. Longeing is only allowed in the dedicated longeing area.
26. The warm-up area is open one hour before the show opens each day and for one hour at the end of day on Friday and Saturday for schooling.
27. Show correspondence will be handled through email. Ride times will be posted on the Blackhorse One website once they are ready. Riders are responsible for checking the day sheets as ride times may change. Please provide a correct email on your entry form.
28. It is a condition of entry that neither the show organizing committee, CEDF nor Rocky Mountain Show Jumping will be held responsible in any way for damage, injury or loss to persons, horses or property of spectators or competitors.
29. Dogs must be kept on a leash at all times. Smoking is not allowed in the stabling areas or indoor arena.
30. Horses must leave the show grounds within 2 hours of classes ending on the show's last day. Any arrangements to stay extra time must be made in advance with RMSJ.
31. All parking is across the road from the Show Grounds, except during trailer loading and unloading. No exceptions
32. Stabling is available but not mandatory. Stabling opens at 1:00 pm on move-in day, before the show begins. The stabling fees include two bags of shavings. Additional shavings will be sold by pre-order on the entry form or at the Tilted Tiara on-site show office.
33. Competitors not stabled will be charged a daily haul-in fee. The haul-in horses may not tie to stalls in the stabling area, and they should be kept by their trailer in the parking area across the road from the show grounds.
34. All stabled horses (including day stalls) must pay the mandatory environmental fee.
35. A stabling chart will be provided at the start of the shows. It can be found at the show office and in the barns. Competitors may only use the stall and tack stall assigned to them. Any changes to stabling should be discussed with the show office.
36. Free parking is available across the road. Registered coaches with students in the show will receive complimentary parking in a designated area, as will as para-equestrian competitors. No other parking within the stabling area is allowed unless a parking pass has been purchased. No exceptions.
37. No outside shavings allowed. Shavings orders made by noon on Friday and Saturday, will be delivered in that afternoon.
38. Competitors will be charged a \$50 stall cleanout fee. If the stall is cleaned out at the end of the event, the \$50 will be refunded.

Show Championships

The average of all championship tests ridden will be used to determine the Show Champions and Reserve Champions. At least two (2) tests must be ridden to be eligible for show championships. The highest average will be used to determine the Show Champion, and the second highest average will be used to determine the Show Reserve Champion. Only classes specified as Championship Classes will count towards championships.

These are the planned show championships. The organizing committee can combine or split championships depending on entries.

Eventing is an equestrian competition with three phases: Dressage, Cross-Country, and Show Jumping, testing precision, bravery, and agility. Thanks to this great partnership, we're excited to offer the following opportunities for riders of all levels:



Eventing Dressage Tests – Friday and Saturday

- Riders can enter and ride eventing dressage tests throughout the competition.



ShowJump Rounds – Friday & Saturday

Format: Clear Rounds (for schooling purposes only)

Rounds follow standard jumper rules, including elimination for refusals, off-course, or falls.

- **Friday: 10:00 AM – 4:00 PM**
Heights will start at 0.60m and increase progressively to a maximum of 1.30m, as warranted by entries.
- **Saturday: 9:00 AM – 3:00 PM**
Heights will start at 1.30m and decrease progressively, as warranted by entries.

Each horse may enter up to 4 rounds per day, with a maximum of 2 rounds per height class per day. Fee is \$50 per horse, per day – includes all rounds for that day. No prizes awarded.



Combined Test – Dressage and ShowJumping Competition – Sunday

A **Combined Test** is a fun and approachable way for riders to gain experience in two phases of Eventing – **Dressage** and **ShowJumping** – without the cross-country portion.

- **Dressage:** Begins at **9:00 AM**, starting with the lowest levels and will continue progressively through the levels.
- **ShowJumping:** Takes place approximately 1 hour after each rider's dressage test.

How it works:

- Dressage is scored in **penalty points** (lower is better!).
- Show jumping penalties (such as **knocked rails**, **refusals**, or **time faults**) are added to the dressage score.
- 🏆 The rider with the **lowest combined score** wins their division!

To help riders prepare for future cross-country phases, derby-style jump options will be included in the combined test stadium course – such as shoulder brush jumps and corners – providing great exposure in a safe, friendly setting. This is a perfect opportunity for riders to get a feel for competition day, build confidence, and have fun in a supportive and encouraging environment! Derby jumps will be available Friday – Saturday as an option in jumper rounds.

Young Horse Championships

The Tilted Tiara Young Horse FEI championships feature competitions for: 4-year-old, 5-year-old, 6-year-old and 7-year-old dressage horses. The primary focus of the competitions is on evaluating the quality of the horse's gaits, rideability, and overall potential for future dressage success and the horses competing in the FEI Young Horse classes and are judged by panel of three FEI judges with FEI-YR credentials.

New for 2025, Tilted Tiara is also offering a Wild Rose Young Horse competition for: 3-year-old, 4-year-old and 5-year-old horses. These horses will compete in a Materiale classes by age, a dressage test of choice, and the mini-classic for young horses.

These championships provide an opportunity for breeders, trainers, riders, and owners to present their young horses and gain recognition for their breeding programs and training methods. It also serves as a valuable learning experience for riders and trainers to gain insights into the development and training of young dressage prospects.

Tilted Tiara Terrific Classic – 2025 Format

This year, the **Tilted Tiara Terrific Classic** will be run as four separate events:

- **Junior Mini-Classic**
- **Adult Mini-Classic**
- **Young Horse Mini-Classic**
- **Terrific Classic** (regular division with a more advanced test and higher jumps)

The Terrific Classic is a two-phase competition that combines dressage and jumping, requiring riders to compete on the same horse for both phases.

Competition Format

✅ Phase 1: Dressage Test

- The **Mini-Classics** will feature a short test including walk, trot, canter, lengthenings, and leg yields.
- The **Terrific Classic** will include half-passes and flying changes in addition to the above movements.
- The dressage tests will be available on the Tilted Tiara website one month before the event.
- Riders can opt to include **bonus movements** to earn extra points.

✅ Phase 2: Jumping Round

- Scored on a "**match the clock**" format while minimizing knockdowns.
- Maximum jump heights:
 - **Mini-Classics: Up to 18"**
 - **Terrific Classic: Up to 30"**
- Riders can earn **extra points** by choosing higher jumps.

Prize Money & Awards

- **\$3,000** in prize money will be awarded to the top 10 riders in the **Terrific Classic**.
- **\$400** for the top 6 riders in the **Young Horse Mini-Classic**.
- **\$300** for the top 6 riders in the **Junior Mini-Classic**.
- **\$300** for the top 6 riders in the **Adult Mini-Classic**.
- Medal presentations and prize distribution will take place **Saturday evening at Goby's Grill**.
- All horse show participants and sponsors are invited to the celebration!

Air Quality Guidelines

Tilted Tiara follows Equestrian Canada’s (EC) guidelines for air quality to ensure the safety and well-being of both horses and athletes. We use the **Air Quality Health Index (AQHI)** provided by **Environment and Climate Change Canada** to assess conditions during the event.

Competition Adjustments Due to Air Quality

- If the **AQHI reaches 7 or higher (High Risk)**, competition and training schedules may be modified or postponed at the discretion of the Organizing Committee. Adjustments will be communicated to all participants.
- If the **AQHI reaches 10 or higher (Very High Risk)**, all competition and training will be **cancelled or rescheduled**.

Responsibility of Participants

- Riders, coaches, and officials are encouraged to monitor AQHI reports leading up to and during the event.
- Those with respiratory sensitivities or concerns should take extra precautions and consult with a medical professional if needed.
- Stabling areas will be monitored to ensure horses are not experiencing distress due to air quality conditions.

For more details on air quality considerations in equestrian sport, please refer to **EC’s Guidelines for Equine Competition and Training During Extreme Environmental Conditions**.

RMSJ Health and Safety Protocol



Rocky Mountain Show Jumping has implemented a Health & Biosecurity Protocol to decrease the risk of introduction and/or spread of contaminants, contagious or infectious diseases by movements of horses onto or off the venue.

Health Requirements

1. You must provide proof of vaccination for ALL of your horses on the grounds, showing or not. Required vaccinations are: Equine Influenza and EVH 1 & 4 (Rhino) within 6 months (180 days) but not within 7 days of arrival on the grounds.
2. Keep copies of your vaccination records in your tack room or in your truck/trailer. You may be asked by Tilted Tiara personnel to present your health papers at any time.
3. If you ship in and out daily, keep copies of your vaccination records in your truck/trailer. You may be asked to present these records.
4. If proper records are not immediately available, the horse(s) will be asked to leave the grounds.

Direct and Indirect Contact Between Horses and People

The most common path for spreading germs and disease is contact among horses, humans and other animals. Bodily fluids such as nasal discharge, saliva and sweat can carry germs which are easily transmitted from horse to horse through direct and indirect contact.

- Limit horse-to-horse contact.
 - Limit horse-to-human-to-horse contact.
 - Limit horse-to-dog (other animal)-to-horse or horse-to-dog-to-human-to-horse contact.
1. Dogs are permitted in the stabling area only. Dogs must be on a leash controlled by a human. Loose dogs will not be tolerated.
 2. Restrict unnecessary movement of horses out of their aisle or barn.
 3. Do not lead horses down other tent/barn aisles.
 4. Don't let horses make nose-to-nose contact.
 5. Do not touch or pet, or feed treats to horses.

Soiled Equipment

Soiled equipment is another common path for spreading germs and disease. Nasal discharge, saliva, sweat, and even soiled bedding can carry microbes and spread them via shared items such as tack, equipment, hoses, buckets, grooming supplies and towels.

1. **Do not let water hoses touch buckets when filling.** Contact with a contaminated surface on a water bucket can be easily transmitted to the next bucket contacted.
2. **Do not allow horses to drink from the hose.**
3. **Do not share water or feed buckets.**
4. **Have hand sanitizer readily available,** and use it between grooming/tacking up horses. Keep it handy in the grooming stall, on your golf cart, and in your grooming box at the ring
5. **Use clean brushes and towels on each horse.** If you don't have enough brushes for each horse to have his own set, be sure to wash them often.
6. **Don't share tack and equipment,** especially bits and bridles, unless they are cleaned between each use.

BIO-SECURITY MEASURES

Protecting the health of your horses is of the utmost importance to Rocky Mountain Show Jumping. Rocky Mountain Show Jumping has compiled this list of Bio-Security Regulations for decreasing the risk of exposure or spread of disease.

1. Be sure to read the Bio-Security regulations, it reviews simple steps we all can take to keep horses healthy!
2. **Horses Temperature** is an easy way to monitor your horse. Take and record your horse's temperature twice daily when it is at rest and NOT immediately following exercise and trailering. The horse's temperature should be below 102°F
3. Trainers – please let your braider know about the new Bio-Security regulations.

RMSJ CONTINGENCY PLAN

Monitor your horses and contact TD Equine Veterinary Group at 403-691-9808 if you notice any unusual symptoms. Any sick or suspect horses are to be reported to the veterinary staff and will be separated and taken to isolation stalls for testing and observation.
