Equestrian Canada Statement of Principle

Equestrian Canada (EC), the national equestrian federation of Canada, supports adherence to humane treatment of horses in all activities under its jurisdiction.

All persons shall be committed to:

- Upholding the welfare of horses, regardless of value, as a primary consideration in all activities;
- Requiring that horses be treated with kindness, respect, and compassion, and that they never be subjected to mistreatment.
- Ensuring that owners, trainers and exhibitors or their agents use responsible care in the handling, treatment and transportation of their horses as well as horses placed in their care for any purpose.
- Providing for the continuous well-being of horses by encouraging routine inspection and consultation with health care professionals and competition officials to achieve the highest possible standards of nutrition, health, comfort and safety as a matter of standard operating procedure.
- Continuing to support scientific studies on equine health and welfare;
- Requiring owners, trainers, and exhibitors to know and follow their sanctioning organization's rules and to work within industry regulations in all equestrian competitions;
- Reviewing, revising and developing competition rules and regulations that protect the welfare of the horses

The standard by which conduct or treatment will be measured is that which a person who is informed and experienced in generally accepted equine training and exhibition procedures would determine to be neither cruel, abusive, nor inhumane.

Gold Show Information

The Tilted Tiara competition is sanctioned as a Platinum competition of Equestrian Canada c/o House of Sport 2451 Riverside Drive, Ottawa, Ontario, K1H 7X7 and is governed by the rules of EC. (A602.1)

Every class offered herein is covered by the rules and specifications of the current rules of EC and will be held and judged in accordance with the EC Rule Book. (A602.2)

Per Article A801, every entry at an EC-sanctioned competition shall constitute an agreement by the person(s) responsible that the owner, lessee, trainer, manager, agent, coach, driver or rider and horse shall be subject to the EC constitution and all rules of EC and any additional rules set by the competition. It is the responsibility of all individuals participating in any capacity in EC-sanctioned competitions to be knowledgeable regarding the EC constitution and the applicable rules of EC and the additional rules, if any, imposed by the competition. Do not participate in this EC-sanctioned competition in any capacity if you do not consent to be bound by the constitution and rules of EC and any additional rules imposed by the competition. (A602.7)

When registering for EC sanctioned competitions, athletes must indicate the name of their coach on the entry form or specify that they are self-coached. Coaches from other countries, must be in good-standing with their home federation and must declare/have proof of insurance. See Rules of Equestrian Canada, Section A, General Regulations, Article 102, Safe Sport Environments.

All horses attending Equestrian Canada sanctioned competitions must have met the requirements of Article A519, Vaccinations. See Rules of Equestrian Canada, Section A, General Regulations, Article A519, Vaccinations (A602.8)

Any horse entered in any class at a competition may be selected for equine medication control while at the event location. (A602.5)

In order to enter a horse in an EC sanctioned competition, you must designate a Person Responsible (PR). The PR must be an adult who has or shares responsibility for the care, training, custody and performance of the horse, and who has official responsibility for that horse under EC Rules. The PR is liable under penalty provisions of the applicable EC Rules for any rule violations. Every entry form for an EC sanctioned competition must identify the PR and be signed by the PR.

EC Gold Sport licences are required for the rider and the horse's owner. The competitor or owner that holds an EC license at a lower level, may pay a single-event upgrade fee to compete. The fee must be paid through the Equestrian Canada portal. The single-event Sport licence Upgrade is valid only for that competition.

Tilted Tiara will have identification for all coaches in the EC-sanctioned part of the show available at the show office. The ID must be worn while coaching on the show grounds for riders in the CDI or Gold Show. The badges are to be returned to the show office at the conclusion of the show.



EC SPORT LICENSING 2024

SAFETY, INCLUSIVITY, & EXCELLENCE

Your guide to the latest updates for the competition season in Canada

IMPORTANT CHANGES have been implemented to enhance the safety and inclusivity of equestrian sport. Whether you're an athlete, parent, coach, official, or competition staff, your role is crucial in upholding these standards. Here's what you need to know:

SAFE SPORT TRAINING PREREQUISITE:

- The two free EC Safe Sport training modules must be completed before purchasing a Sport Licence. Check your training status on MyEC by clicking on the ECampus button.

DISCONTINUED TEMPORARY LICENCES:

- Temporary EC Sport Licences are now discontinued at competitions. All riders, owners, and coaches must possess an EC Sport Licence to participate in events.

AVAILABLE SHOW LEVEL UPGRADES:

- Explore higher-level competitions with temporary upgrades via your MyEC Portal. Note: National Rankings Points are not tabulated for upgraded results.

COACH STATUS REQUIREMENTS:

- All coaches at EC-sanctioned events require EC Licensed Coach Status. For upgrading from Registered to Licensed Status, coaches can apply for a Temporary Coach Status (TCS) to fulfill the requirement for each event.
- New for 2024: A TCS may be purchased conveniently online via the MyEC Portal only. Each TCS is valid for a single event.

EMPOWERING SELF-COACHED ATHLETES:

- Athletes without a designated coach can declare themselves as self-coached by providing their name and EC Sport Licence number on their entry form.

CDI Information

All CDI horses must arrive from 10:00 am to 2:00 pm on May 23.

The CDI horse inspection is at 4:00 pm on May 23.

All CDI horses stabled in the secured FEI barns must follow the new FEI protocols

In accordance with Art. 1029 and 1031 of the FEI 2024 Veterinary Regulations, ALL horses competing at ALL FEI events worldwide must fulfill the Horse Health Requirements via the FEI HorseApp.

Main Requirements:

1. Take two daily temperature readings for every Horse that will be present at an FEI Event for the three days leading up to the day of arrival and enter these recordings in the FEI HorseApp.
2. Fill in a Horse Health FEI Self-Certification form for all Horses attending an FEI event.


To be filled in and submitted via the FEI HorseApp the day before or the day of arrival at the CDI.

3. Take the temperature of each Horse twice a day at the CDI using your own thermometer and record the measurements directly in the FEI Horse App.

FEI Passports: FEI Passports are not required if competing in their home country. However, these horses must have a National Passport, be registered with their NF, be identifiable by a diagram, and have a valid vaccination certificate.

Prize Giving. The top three (3) to return for awards ceremonies. The CDI Prizes will include Neck Sashes for first through third places and ribbons for fourth to sixth places. Failure to appear for an awards ceremony will entail the elimination of a competitor from the class. If a horse cannot participate due to safety reasons, permission to not participate must be given by the OC/Chief Steward/Ground Jury before the ceremony.

CDIAM: Athletes from 26 years. Athletes must have no ranking on the FEI Dressage World Ranking List at the date of their definite entry. Limit of 2 horses per athlete. Prix St. Georges, Intermediate I, Intermediate I Freestyle.

CDI1*: Prix St. Georges, Intermediate I, Intermediate I Freestyle. Limit of 2 horses per athlete. Freestyle is not compulsory.

CDI2*: Intermediate B, Intermediate II. Intermediate A/B Freestyle: Limit of two horses per athlete. Freestyle is not compulsory.

CDI3*: Grand Prix, Grand Prix Special, Grand Prix Freestyle. Limit of two horses per athlete. Athletes must opt for either the Grand Prix Special or the Grand Prix Freestyle.

CDIJ*: Juniors Team, Juniors Individual, Juniors Freestyle. Limit of two horses per athlete. Freestyle is not compulsory.

CDIYR*: Young Rider Team, Young Rider Individual, Young Rider Freestyle. Limit of two horses per athlete. Freestyle is not compulsory.

CDIU25*: Intermediate II, Grand Prix 16-25, Grand Prix Freestyle. Limit of two horses per athlete. Freestyle is not compulsory.

Wild Rose Show Information

The Tilted Tiara I Competition is sanctioned as an Alberta Wild Rose Competition: EC and FEI tests are offered at the Wild Rose Show. Alberta Equestrian Federation Wild Rose-sanctioned competitions are to be run in accordance with the AEF Wild Rose Rules.

Entries in the Wild Rose show only require an AEF (or other Provincial) membership for the rider. Western Dressage tests are offered as part of the Wild Rose show. All classes in the Wild Rose show are not rated for EC awards.

Entry Information Gold & Wild Rose

Rules

01. All entries must be submitted through Compete Easy. Any competitor that wishes to have a paper entry processed, must include a valid credit card number along with the entry. All entries will be charged a processing fee of 5.65%.
02. Entries for the Gold and Wild Rose shows will be processed in the order they are received. The organizing committee reserves the right to limit or refuse entries subject to championship rules limiting a competition's right to refuse entries. A805.
03. Riders may pay one administration fee and enter both Gold and Wild Rose classes.
04. The Master's Test of Choice Class is an EC dressage class that provides senior riders, 60 and older, the opportunity to participate in a dressage class that is exclusively their own that provides a fair playing field for senior riders wherein each will compete against their peers at all levels of skill, from beginner to advanced. The class will feature one test per day. Please review EC rules for the list of accommodations available.
05. Please submit your Freestyle Music when registering; the music must be electronic. Please email the show secretary with the music file.
06. Gold entries must pay a mandatory DC Levy of \$10, and a mandatory Drug Fee of \$8.
07. Late entries will be accepted, space permitting, with a late fee.
08. Post entries to fill scratches will be allowed if scheduling permits. To be eligible for post-entry into classes, the horse/rider must already be registered as a competing or non-competing horse and must arrange the additional classes with the show secretary.
09. All entries must have the signature of the owner or authorized agent and the signature for the person(s) responsible for the horse. Riders will not be allowed to compete without a person(s) responsible signature.
10. Junior riders must have permission to participate in the show as indicated by the signature of a parent or guardian.
11. Hors Concours entries will be accepted with full fees. Entrants are subject to EC or AEF rules, and Hors Concours entries are not eligible for ribbons or awards.
12. Non-competing (schooling horses) will be accepted. Entries must pay the administration fee, a non-competing horse fee and stabling fees. Schooling horses do not require a horse recording. Riders must have proof of AEF or provincial membership.
13. Riders may scratch their entry through Compete Easy.
Before the entries closing date, the scratch fee is \$50.
After the closing date and before May 21 at 6 pm, the scratch fee is \$180.
After May 22 at 1pm, and prior to May 23 at 6 pm, the scratch fee is \$280.
Compete Easy will refund all fees in excess of the scratch fee to your credit card. All stabling, shavings, classes, ride times etc, will revert to Tilted Tiara, who will reassign if possible.
14. Horse substitutions are allowed until one hour before the horse competes in their class. The name of the horse, any required licences and the owner or person(s) responsible signatures must be given to the show secretary when the substitution is made.
15. All athletes, regardless of age or level of competition, must wear properly fitted and fastened safety approved protective headgear at all times when mounted at any EC-sanctioned Dressage competition at the event location. (E.4.0).
16. Exhibitors must be ready to compete when scheduled.
17. The horse may compete at any level up to a maximum of four tests per day, including the freestyle e.g. one horse could compete on a total of four technical tests, with two different riders each riding two tests. The horse may compete only in



two consecutive levels. Horses competing at second level and above can only compete in three technical tests per day.

18. The show will provide no test readers.
19. Every entry must have an identification number worn and visible on the show grounds.
20. Any horse receiving less than 50% of the total points obtainable in a test shall not be eligible for awards, ribbons, or prizes. (E9.10.7)
21. When there is only one horse in a class, ribbons and prizes shall be awarded in accordance with the following chart of percentages:

1st	63% or higher
2nd	60% to 62.9%
3rd.....	58% to 59.9%

No ribbons or prizes shall be awarded below 3rd position. (E9.9.10)
22. Class ribbons can be picked up at the show office.
23. Class ribbons will be given to 6th place.
24. Warm-up in the show rings is allowed on the move-in day from 1:30 PM until 7:30 PM. Horses that are not stabled on the grounds may also haul-in on move-in day and school in the show rings. Schooling in the show rings is also allowed for one hour after the last rider in that ring on the first show day. Longeing is only allowed in the dedicated longeing area.
25. The warm-up area is open one hour before the show opens each day and for one hour at the end of day on Friday and Saturday for schooling.
26. Show correspondence will be handed through email and Compete Easy. Ride times will be posted on the Tilted Tiara website once they are ready. Riders are responsible for checking the day sheets as ride times may change. Please provide a correct email on your entry form.
27. It is a condition of entry that neither the show organizing committee nor Rocky Mountain Show Jumping will be held responsible in any way for damage, injury or loss to persons, horses or property of spectators or competitors.
28. Dogs must be kept on a leash at all times. Smoking is not allowed in the stabling areas or indoor arena.
29. Horses must leave the show grounds within 2 hours of classes ending on the show's last day. Any arrangements to stay extra time must be made in advance with RMSJ.
30. All parking is across the road from the Show Grounds. No exceptions except during trailer loading and unloading.
31. Stabling is available but not mandatory. Stabling opens at 1:00 pm on move-in day, before the show begins. The stabling fees include two bags of shavings. Additional shavings will be sold by pre-order on the entry form or at the Tilted Tiara on-site show office.
32. Competitors not stabled will be charged a daily haul-in fee. The haul-in horses may not tie to stalls in the stabling area, and they should be kept by their trailer in the parking area across the road from the show grounds.
33. All stabled horses (including day stalls) must pay the mandatory environmental fee.
34. A stabling chart will be provided at the start of the shows. It can be found at the show office and in the barns. Competitors may only use the stall and tack stall assigned to them. Any changes to stabling should be discussed with the show office.
35. If you want to be stabled next to someone in particular, please ensure that the same stable group name is used on the entry form. Every attempt will be made to accommodate special requests when assigning stalls, but no guarantees can be made.

Show Championships

The average of all championship tests ridden will be used to determine the Show Champions and Reserve Champions. At least two (2) tests must be ridden to be eligible for show championships. The highest average will be used to determine the Show Champion, and the second highest average will be used to determine the Show Reserve Champion. Only classes specified as Championship Classes will count towards championships.

These are the planned show championships. The organizing committee reserves the right to combine or split championships depending on entries.

CDI and Young Horse Championship presentations will be held at Sunday's end of their classes. Horses are required at these presentations.

Gold and Wild Rose Championship presentations will be held at the end of the show. Horses are not required at the presentations, but the rider must be present, dressed in their show attire.

Other special prizes will be awarded depending on sponsorship.

Riders Gifts

At each 2024 Tilted Tiara Show, riders who earn three first-place finishes can choose a special gift. Look for fabulous gifts donated by our sponsors at the gift table outside the show office.

Young Horse Championships

The Tilted Tiara Young Horse championships feature competitions for: 4-year-old, 5-year-old, 6-year-old and 7-year-old dressage horses. The primary focus of the competitions is on evaluating the quality of the horse's gaits, rideability, and overall potential for future dressage success.



The championships provide an opportunity for breeders, trainers, riders, and owners to present their young horses and gain recognition for their breeding programs and training methods. It also serves as a valuable learning experience for riders and trainers to gain insights into the development and training of young dressage prospects.

The FEI Judges, a panel of international dressage experts, evaluate each horse's performance in designated dressage tests specifically designed for young horses. These tests assess the horse's ability to execute basic movements such as walk, trot, canter, and transitions, as well as their suppleness, balance, and willingness to work. Each competition will be judged by a panel of three FEI Young Horse judges.

The championships are a significant event for the dressage community in Alberta. They provide a platform for networking, education, and the exchange of ideas related to breeding, training, and developing top-quality dressage horses.

Canadian Warmblood Incentive

The Canadian Warmblood Breeders Association Alberta Chapter is offering \$300 for the top CWB in each of the Young Horse Championships. The prize money will be split between the horse's owner and breeder.

Terrific Classic

The Tilted Tiara Terrific Classic is a combination dressage and jumping test. Riders will ride a dressage test in the upper ring. Immediately following the dressage test, they will enter the jumper ring and ride a jumper round. Competitors must use the same horse in both phases.

In phase 1 of the class, a short custom dressage test will be ridden with walk, trot, canter, lengthenings, and leg yields/half-passes. The dressage test will be posted on the website at least one month before the competition. There will be optional movements for extra points.

In phase 2 of the competition (the jumping round), scoring will be based on "match the clock" while minimizing knockdowns. Jumps will be at most 18". Similar to the dressage test, extra points can be earned by jumping higher jumps.

Prize money will be distributed after the class. There will be at least \$2,000 to be allocated to the top 10 riders. The medal presentation and prize money will be awarded at **Goby's Grill after the Terrific Classic Class**. All horse show participants and sponsors are invited to the medal presentations and celebration on Saturday evening.

Dog Costume Class

Dress up your dog and compete in the dog costume class at the end of the show day on Friday!! Doggie cookies for all, and may the best dog win. To be judged by an esteemed panel of International Judges.

Sponsor and Awards Event at Goby's Grill

Sponsors, riders, coaches, grooms and spectators are all invited to Goby's Grill on Saturday night, thirty minutes after classes end. Draws and prizes for all riders will be made and prize money and ribbons from the Terrific Classic will be awarded, BUT you need to be there!!

RMSJ Health and Safety Protocol

Rocky Mountain Show Jumping has implemented a Health & Biosecurity Protocol to decrease the risk of introduction and/or spread of contaminants, contagious or infectious diseases by movements or horses onto or off the venue.



Health Requirements

1. Proof of negative coggins is required and must be dated within the last 12 months.
You must provide proof of vaccination and coggins for ALL of your horses on the grounds, showing or not. Required vaccinations are: Equine Influenza and EVH 1 & 4 (Rhino) within 6 months (180 days) but not within 7 days of arrival on the grounds.
2. Keep copies of your vaccination records in your tack room or in your truck/trailer. You may be asked by Tilted Tiara personnel to present your health papers at any time.
3. If you ship in and out daily, keep copies of your vaccination records in your truck/trailer. You may be asked to present these records.
4. If proper records are not immediately available, the horse(s) will be asked to leave the grounds.

Direct and Indirect Contact Between Horses and People

The most common path for spreading germs and disease is contact among horses, humans and other animals. Bodily fluids such as nasal discharge, saliva and sweat can carry germs which are easily transmitted from horse to horse through direct and indirect contact.

- Limit horse-to-horse contact.
 - Limit horse-to-human-to-horse contact.
 - Limit horse-to-dog (other animal)-to-horse or horse-to-dog-to-human-to-horse contact.
1. Dogs are permitted in the stabling area only. Dogs must be on a leash controlled by a human. Loose dogs will not be tolerated.
 2. Restrict unnecessary movement of horses out of their aisle or barn.
 3. Do not lead horses down other tent/barn aisles.
 4. Don't let horses make nose-to-nose contact.
 5. Do not touch or pet, or feed treats to horses.

Soiled Equipment

Soiled equipment is another common path for spreading germs and disease. Nasal discharge, saliva, sweat, and even soiled bedding can carry microbes and spread them via shared items such as tack, equipment, hoses, buckets, grooming supplies and towels.

1. **Do not let water hoses touch buckets when filling.** Contact with a contaminated surface on a water bucket can be easily transmitted to the next bucket contacted.
2. **Do not allow horses to drink from the hose.**
3. **Do not share water or feed buckets.**
4. **Have hand sanitizer readily available,** and use it between grooming/tacking up horses. Keep it handy in the grooming stall, on your golf cart, and in your grooming box at the ring
5. **Use clean brushes and towels on each horse.** If you don't have enough brushes for each horse to have his own set, be sure to wash them often.
6. **Don't share tack and equipment,** especially bits and bridles, unless they are cleaned between each use.

BIO-SECURITY MEASURES

Protecting the health of your horses is of the utmost importance to Rocky Mountain Show Jumping. Rocky Mountain Show Jumping has compiled this list of Bio-Security Regulations for decreasing the risk of exposure or spread of disease.

1. Be sure to read the Bio-Security regulations, it reviews simple steps we all can take to keep horses healthy!
2. **Horses Temperature** is an easy way to monitor your horse. Take and record your horse's temperature twice daily when it is at rest and NOT immediately following exercise and trailering. The horse's temperature should be below 102°F
3. Trainers - please let your braider know about the new Bio-Security regulations.

RMSJ CONTINGENCY PLAN

Monitor your horses and contact TD Equine Veterinary Group at 403-691-9808 if you notice any unusual symptoms. Any sick or suspect horses are to be reported to the veterinary staff and will be separated and taken to isolation stalls for testing and observation.
